## 1.4. The amount of fixed costs

The amount of fixed costs for all study programmes is 5,000.00 dinars per semester.

## 1.5. Foreign Citizen Students

The tuition fee for foreign students in first-level studies is 2,000.00 EUR, and the cost per credit is 33.35 EUR.

The tuition fee for foreign students in the vocational studies programme in Optometry is 3,500.00 EUR, and the cost per credit is 58.35 EUR.

The tuition fee for foreign students in the master vocational degree programme in Optometry is also 3,500.00 EUR. The cost per credit is 58.35 EUR, as well as for master academic studies: Master of Science in Biology, Master of Science in Ecology, Ecotourism and Environmental

Protection, Master of Science in Reproductive Biology, Master of Science in Biology Teaching, Chemistry, Biochemistry, and Environmental Protection. The tuition fee for the master's academic studies in Physics and Physics Teaching is 2,500.00 EUR and the cost per credit is 41.67 EUR.

The tuition fee at the Department of Geography, Tourism, and Hospitality for master studies in Tourism is 3,000.00 EUR, and the cost per credit is 50 EUR. For geography, it is 2,000.00 EUR, and the cost per credit is 33.35 EUR. The tuition fee at the Department of Mathematics and Computer Science for master studies is 2,000.00 EUR, and the cost per credit is 33.35 EUR.

The tuition fee for third-level studies for foreign students is 5,000.00 EUR and the cost per credit is 83.35 EUR for the study programmes PhD in Biological Sciences, PhD in Molecular Biology, PhD in Chemistry, PhD in Biochemistry, and PhD in Environmental Protection. The tuition fee for PhD in Computer Science and PhD in Mathematics is 2,500.00 EUR and the cost per credit is 41.70 EUR; for PhD in Geographical Sciences and PhD in Tourism, the fee is 4,000.00 EUR and the cost per credit is 66.67 EUR; for the study programs PhD in Ecological Sciences and PhD in Physics, the fee is 3,500.00 EUR and the cost per credit is 58.35 EUR; and for PhD in Teaching Methodology of Natural Sciences, the tuition fee is 3,000.00 EUR and the cost per credit is 50 EUR.

- 1.6. Transfer of points for final thesis/master's thesis and doctoral dissertation to the new academic year is not charged.
- 1.7. The cost of ECTS credits for attended, unpassed subjects that students choose again at all levels of study is 500.00 RSD.

Tuition fees for self-funded students in higher years are calculated using the formula:

 $TRSH = FT + (CB \times BRB)$  where:

TRSH – the amount of tuition costs for self-funded students in higher years,

FT - the amount of fixed costs,

CB – the price of credit for the academic year of the study programme the student is enrolling in (from Table 1.1.a. or Table 1.1.b. or Table 1.1.c.),

BRB – the total number of ECTS credits of the subjects the student chooses to attend from the study programme they are enrolling in.
